

Safe Standard® – Country Annex: Turkmenistan / Türkmenistanyň Respublikasy (2025.1 Public Template)

Valid only for rentals occurring within Turkmenistan.

ENGLISH VERSION

1. National Legal Basis Relevant Turkmen laws: • Civil Code of Turkmenistan – contracts, obligations, liability • Law on Consumer Protection • Law on Electronic Document, Electronic Document Management and Digital Signature • Product Safety & Standards — Main State Service 'Turkmenstandartlary' • Civil Procedure Code Jurisdiction: court where the rental occurs unless both parties agree otherwise. Private rental agreements are valid under Turkmen civil-law principles.
2. Tax and Reporting Rental income is taxable. VAT: • Standard VAT rate: 15% Record keeping: minimum 5 years (State Tax Service of Turkmenistan).
3. Liability and Insurance Liability requires: • negligence or fault • actual provable damage • causation Gross negligence or intentional harm cannot be excluded. Template limits: • USD 270 per rental • USD 900 for Mobility (Valid unless overridden by mandatory national law.) Recommended insurance: • Public liability insurance • Business/equipment insurance
4. Consumer Rights & Withdrawal Consumer Protection Law applies. No EU-style 14-day withdrawal right for date-specific rentals. Refund rules: • Before handover: as agreed • After handover: only if unsafe, defective or unusable
5. Data Protection Turkmenistan does not have a GDPR-equivalent unified data-protection law. Safe Standard® stores no personal data; Stripe processes all payments. General confidentiality norms apply.
6. Enforcement & Cross-Border Cases Handled by Turkmen civil courts. Foreign judgments require recognition via court procedure. Arbitration allowed with written agreement.
7. Use of Templates in Turkmenistan Annex is internal reference only. Steps: 1. Rental Agreement (Country: Turkmenistan) 2. Focus Checklist at handover 3. Photo Rule — No notes = No damage = No photos 4. Damage Invoice if required 5. Annex is NOT provided to the renter.
