

Safe Standard® – Country Annex: Somalia / Jamhuuriyadda Federaalka Soomaaliya (2025.1 Public Template)

Valid only for rentals occurring within Somalia.

ENGLISH VERSION

1. National Legal Basis Relevant Somali legal framework: • Civil law principles based on mixed civil, Sharia, and customary (Xeer) systems • Contract validity recognized under general civil-law doctrines • Consumer protection rules — no unified nationwide statute; principles vary by region • Electronic Transactions Law — developing/partial framework • Product Safety & Standards — Somali Bureau of Standards (emerging) • Civil Procedure (varies by region and court structure) Jurisdiction: typically local courts where the rental occurs. Contract validity: private rental agreements are enforceable if mutual consent and lawful terms are established.
2. Tax and Reporting Taxation varies by region (Federal Member States). General principles: • Rental income may be taxable depending on region • VAT system not uniformly implemented Record keeping: recommended minimum of 5 years.
3. Liability and Insurance Liability requires: • negligence or fault • verifiable actual damage • causation Gross negligence or intentional acts cannot be excluded. Template limits: • USD 270 per rental • USD 900 for Mobility (Valid unless contrary to mandatory local rules.) Recommended insurance: • Public liability insurance (where available) • Equipment/business insurance
4. Consumer Rights & Withdrawal Somalia has no unified consumer-rights statute. General principles apply: • No 14-day EU-style withdrawal for fixed-date rentals Refund rules: • Before handover: by agreement • After handover: only if item is defective, unsafe, or unusable
5. Data Protection No comprehensive national data-protection law. General privacy norms apply. Safe Standard® stores no personal data; Stripe processes all payments externally.
6. Enforcement & Cross-Border Cases Handled by local civil courts. Foreign judgments may require special recognition and vary by region. Arbitration is allowed if both parties agree in writing.
7. Use of Templates in Somalia Annex is internal reference only. Steps: 1. Rental Agreement (Country: Somalia) 2. Focus Checklist at handover 3. Photo Rule — No notes = No damage = No photos 4. Use Damage Invoice if necessary 5. Annex is NOT provided to the renter.
