1. National Legal Basis Relevant Mozambican laws: • Civil Code of Mozambique (contracts, obligations, liability – Portuguese-based) • Consumer Protection Law (Lei de Defesa do Consumidor) • Electronic Transactions Law / E-Commerce Framework • Product Safety & Standards – Instituto Nacional de Normalização e Qualidade (INNOQ) • Code of Civil Procedure
Jurisdiction: court where the rental occurs unless agreed otherwise. Contract validity: private rental agreements are enforceable under Mozambican civil-law principles.
2. Tax and Reporting Rental income is taxable. VAT (IVA): • Standard VAT rate: 16% Record keeping: minimum 5 years (Autoridade Tributária de Moçambique).
3. Liability and Insurance Liability requires: • negligence or fault • actual proven damage • causation Gross negligence or intent cannot be excluded. Template limits: • 270 USD per rental • 900 USD for Mobility Recommended insurance: • Civil liability insurance • Business/equipment insurance
4. Consumer Rights & Withdrawal Consumer Protection Law applies. No EU-style 14-day withdrawal for fixed-date rentals. Refund rules: • Before handover: according to agreement • After handover: only if defective, unsafe, or unusable.
5. Data Protection Mozambique has developing personal-data frameworks; no GDPR-equivalent unified law. Safe Standard® stores no personal data; Stripe processes payments externally.
6. Enforcement & Cross-Border Cases Handled by Mozambican civil courts. Foreign judgments require recognition under local procedure (homologação). Arbitration permitted with written agreement.
