National Legal Basis Relevant Vatican laws: • Vatican Civil Law (canon-law influenced; contracts recognized under civil principles) • Consumer protection principles (general civil-law doctrines) • Electronic Communications & Digital Document rules (Vatican governance) • Product Safety standards — relies heavily on EU/Italian norms • Civil judicial procedures operate through Vatican tribunals Jurisdiction: Vatican courts unless parties agree otherwise. Private rental agreements are valid under Vatican civil-law principles.
2. Tax and Reporting Vatican City does not impose income tax or VAT internally. However: • Vendors may still be subject to Italian or home-country tax obligations • Documentation retention recommended: 5 years
3. Liability and Insurance Liability requires: • negligence or fault • provable actual damage • causation Gross negligence or intentional acts cannot be excluded. Safe Standard® template limits: • 270 USD per rental • 900 USD Mobility (valid unless in conflict with mandatory Vatican/Italian civil norms) Recommended insurance: • Public liability insurance • Equipment/business insurance
4. Consumer Rights & Withdrawal No EU-style 14-day withdrawal rule inside Vatican jurisdiction. Refund rules: • Before handover: per agreement • After handover: only if unsafe, defective or unusable
5. Data Protection Applicable framework: • Vatican data-protection norms (aligning with EU-style privacy standards) Safe Standard® stores no personal data; Stripe processes all payments externally.
6. Enforcement & Cross-Border Cases Disputes handled by Vatican civil tribunals. Foreign judgments require formal recognition. Arbitration allowed by written agreement.
7. Use of Templates in Vatican City Annex is internal reference only. Steps: 1. Rental Agreement (Country: Vatican City) 2. Focus Checklist at handover 3. Photo Rule — No notes = No damage = No photos 4. Damage Invoice if necessary 5. Annex is NOT shared with the renter.
